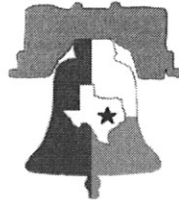
**BILLY WHITE, CHIEF APPRAISER**

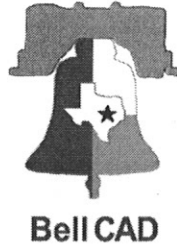
